Ordering

Delivery

We are currently only delivering to the UK. For international orders, please contact museum@stapt.org.uk with a note of where you are and what you wish to order. We will get back in touch with you within 5 working days to advise on postage costs.

The charge for post and packing for all orders sent within the UK is based on a combination of parcel weight, dimensions and value (for insurance purposes).

We aim to dispatch all items within 3 working days of accepting your order, but UK customers should allow up to 7 days for purchases to arrive. Please note that delivery estimates are not guaranteed. You will be notified by email once your goods have been dispatched.

Taxes
